#### 5. IMPORTANT NOTICE

The Summer Schools of Slavonic Studies offering Czech language courses are organised by several public universities in the Czech Republic: Charles University (Faculty of Arts, Prague), Charles University Institute for Language and Preparatory Studies in Poděbrady, Masaryk University (Faculty of Arts, Brno), Palacký University in Olomouc (Faculty of Arts, Olomouc), University of South Bohemia in České Budějovice (Faculty of Arts, České Budějovice) and the University of West Bohemia in Pilsen. The courses are held during the summer months (July – September), their length ranges from 3 to 4 weeks depending on the course content determined by each Summer School and are designed for foreign students, teachers, translators and interpreters and other experts active in the field of Czech/Slavonic studies. Due to their broad scope they are, however, open to anyone else who is interested in the Czech language, literature, history and culture. The Summer Schools offer language courses at various levels of proficiency, seminars on the Czech literature, culture and history, free-time activities including theatrical, musical and dance performances, trips etc.

**Period of Scholarship and Benefits:** The scholarship is provided in the form of free board and lodging, coverage of course fees (tuition and registration fee) and other services which are an integral part of the course programme. A scholarship holder will be provided with free board, lodging and other services covered by the scholarship only during the period of course offered by the respective Summer School.

**Health insurance** is NOT provided to scholarship-holders, who are advised to arrange a medical insurance policy for the period of their stay in the Czech Republic. More information can be provided by the consular section of the Czech Embassy in your country; EU/EEA medical insurance system is described on the website of the Health Insurance Bureau.

**Visa** – Information on the conditions of entry and residence of foreign nationals in the Czech Republic is available on the <u>website</u> of the Ministry of Foreign Affairs of the Czech Republic.

A scholarship holder is obliged, once he/she receives information on acceptance, to confirm his/her attendance at the Summer School by sending a message to the contact e-mail <a href="mailto:posta@msmt.cz">posta@msmt.cz</a> and/or to the relevant contact at the Summer School (see below). If an admitted scholarship-holder cannot attend the Summer School concerned, he/she is obliged to inform the relevant contact person at the Summer School immediately.

By filing this application for the MEYS scholarship, I hereby acknowledge that my personal data provided in the application form and attachments thereto submitted for the purpose of selection proceedings as well as for the purpose of my possible later nomination will be processed by the respective diplomatic mission of the Czech Republic, by the Ministry of Education, Youth and Sports of the Czech Republic, by the Czech National Agency for Education and Research and by the appropriate host university or universities in the Czech Republic, to the extent that is necessary to address my application, in compliance with the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation). I also hereby acknowledge the fact that my aforementioned personal data will be

forwarded to other state authorities in the Czech Republic provided that it is necessary for the processing of my scholarship application, and information on the outcome of my application will be conveyed to the respective nominating agency, i.e. to the appropriate diplomatic mission of the Czech Republic or the respective authority of the foreign state concerned. <u>Detailed information on scholarships for Greek citizens to participate in the Summer Schools</u> <u>of Slavonic Studies in the Czech Republic in 2023 and Instructions how to apply</u>

**Three (3) scholarships** will be granted for Greek citizens to participate in the Summer Schools of Slavonic Studies in the Czech Republic in 2023, in compliance with Article 5b) of the Programme of Educational and Cultural Co-operation between the Government of the Czech Republic and the Government of the Hellenic Republic.

- **A)** One scholarship has been assigned for the Summer School of Slavonic Languages at the **Faculty of Arts of Charles University in Prague** the course will be held from **20 July 2023 to 17 August 2023**, detailed information can be found on: <a href="Prague">Prague</a> info 2023 EN.pdf, MŠMT ČR (msmt.cz).
- B) The second scholarship has been assigned for the Summer School of Slavonic Studies at the Faculty of Arts of Masaryk University in Brno the course will be held from 22 July 2023 to 19 August 2023, detailed information can be found on: Summer School of Slavonic (Czech) Studies | Department of Czech for Foreigners (muni.cz).
- **C)** The third scholarship has been assigned for the Summer School of Slavonic Studies at the **Faculty of Arts of Palacký University in Olomouc -** the course will be held from 15 July 13 August 2023.

Greek citizens can apply only for the courses organized at the three aforementioned universities. Only those who will have completed 18 years on the 1<sup>st</sup> day of the course can apply.

The scholarship covers tuition, board, accommodation and excursions organised as part of the respective summer school course programme. For more information applicants can visit: Summer Schools of Slavonic Studies 2023, MŠMT ČR (msmt.cz).

In this respect, please, notice that other than the herewith-enclosed application form will not be accepted. Applications can also be downloaded from the webpage of the

Ministry of Education, Youth and Sports of the Czech Republic: <u>Application</u> form 2023 SSSS.docx, MŠMT ČR (msmt.cz) Please, make sure that the correct university assigned for applicants from Greece (see above) have been chosen and indicated in the application form.

Apart from a properly completed application form, the below documents have to be part of the application file:

- 1) Candidate's CV in Czech or English.
- 2) Candidate's ID/passport copy.
- 3) Alternatively, other supporting documentation, such as cover/motivation letter resuming why applying for a scholarship, certificates on languages skills and educational background.

In order to speed up and facilitate the process and further communication, the Ministry of Education, Youth and Sports of the Czech Republic kindly asks the candidates and alternates to refer their phone and e-mail addresses in application forms.

Letters of acceptance will be delivered by the respective school directly to the contact addresses of the accepted candidates. It is absolutely necessary that having received a letter of acceptance accepted candidates will immediately confirm by e-mail and also by a letter to the respective school whether they will participate or not.

In case some of the officially nominated and accepted candidates cannot eventually attend the course and withdraw, these candidates are kindly asked to inform **immediately** the Department of International Relations of the Ministry of the Education, Youth and Sports following of the Czech Republic on the fact to the e-mail address: Magdalena.VillatoroSladkova@msmt.cz. These candidates are asked to inform without any delay also the respective summer school they will have been accepted to in order the school could invite an alternate candidate to participate in the course.

Medical care for EU/EEA citizens who are properly insured in their home countries is provided in compliance with the European Parliament and Council (EC) Regulation No. 883/2004, as last amended, and its implementing Regulation No. 987/2009, as amended by Regulation No. 465/2012 - detailed information is available on the website of the Health Insurance Bureau. Please note that the expenses for repatriation are not covered by the provisions of the aforementioned European Regulations, and it is therefore advisable to obtain an insurance policy to this end even if you come from an EU/EEA country. Apart from candidates nominated officially as scholarship applicants by the Greek authorities under the principle of reciprocity, other citizens are also encouraged to apply for the summer school courses - these apply directly to the respective schools and cover the course expenses themselves. The Embassy of the Czech Republic encloses short information about all Summer Courses of Slavonic Studies that will take place in the Czech Republic in the year 2023, including the appropriate contact details.
